Board Member Input on Activities Attended

Bill P. has gotten the COVID-19 vaccine. He has seen his grandchildren and attended task force meetings.

Dick has been attending interesting Wilson Center webinars on the foundations of the Cold War. On Wednesday, it will be two weeks since he and his wife received their second shot, and he is excited to go to a restaurant.

Lisa has been following COVID-19 safety protocols. She participated in the Equity Matters panel at RCC on Sunday. It is sometimes hard to talk about racial equity. There is still much work to be done.

Paul has attended South Lakes High School PTSA meetings. They welcomed teachers back to the building; now students are back. There are about 600 to 700 students at school per day at any one time. Paul attended Human Services Council meetings that discussed the FY22 budget proposal. Paul noted that the Board of Supervisors may lower the real estate tax by 1 cent per \$100 of property value. That's still a net tax increase as assessed value has gone up while in many cases people's incomes have not. There are a lot of community needs (public health, education, housing) that still need to be addressed. Sunday's equity panel discussion was enjoyable, but not a light topic. Paul said he rarely rewatches movies, but he would rewatch *The Last Black Man in San Francisco*.

Bill B. has been to lots of meetings. He is involved in two director searches, one for the Park Authority and one for Public Art Reston. The Equity Matters discussion was interesting. There are signs like voter suppression laws moving to passage that indicate we are still living in Jim Crow America. The Chairman's Task Force on Equity Report has been delivered to the Board of Supervisors. Bill has had his vaccine shots.

Bev took part in the Equity Matters discussion Sunday. She also participated in a "Me and White Supremacy" discussion series at her church. There were only two Black people involved, and it was interesting to see people come to realizations about their own White privilege. She applauds the church community for engaging with the material and subject.

Executive Director's Report

Leila said we are just about two weeks and two days from when we closed a year ago due to COVID-19. The new Strategic Planning Meeting dates are April 23 and 24. The RFP for RCC's website redesign went out on March 1 and will close on March 22, then there will be a selection process and the redesign process. The last aquatics pump is being replaced. That is nearly the final item on the punchlist. Leila

thanks the AARP Tax-Aide volunteers. We are one of only a few places in the area that have figured out how to offer the program safely. That has brought a lot of people into RCC for the first time.

Dick asked about summer camps: has the County changed restrictions on gatherings? Bill B. said the governor's rules on gatherings have changed, so that is being applied to the Park Authority offerings. Bill said he is hoping things will be semi-normal by July. Leila said we will adjust capacities as that becomes feasible. Enrollment is ongoing; if capacity limits change, we will increase capacity. RCC is limited by our square footage and how many kids can be on a bus for our travel camps.

Executive Director Report March 2021

Administration

Administration	
Planning	The Annual Strategic Planning Sessions will be held on April 23, 24 at Reston Association's Conference Center.
Administration	Staff completion of mandated training has been nearly completed and will be complete by the end of the first week of April. Facility rentals for the upcoming year opened to Reston patrons on March 13; there has been a steady influx of rental requests. We have not opened the rental calendar to social events yet. We believe that it would be prudent to forego the restoration of social events until June 1 by which time a larger percentage of adults will have been vaccinated and these events can be held much more safely.
Communications	The RCC website redesign Request for Proposal (RFP) elicited six vendor responses. The Selection Advisory Committee will review those and, if a single vendor emerges as a consensus preference, enter negotiations to contract. Should a couple of submissions rise to the top, a second round of presentations will occur. The timeline for the project is likely to take through the end of December 2021.
Capital Projects	We have received the paperwork for the Sigora solar panels installation; the panels will likely be in place in the first half of July.

Aquatics	We continue to see robust utilization of the lane and warm water pool reservation systems. Learn-to-swim classes are seeing increasing enrollment numbers. About 50 participants enjoyed our first Underwater Egg Hunt event.
Arts and Events	We continue to program cautiously. Vijai Nathan performed for 40 patrons in the CenterStage in March. Founder's Day videos (19) have been completed. South Lakes High School students created an art exhibit for RCC Hunters Woods that was displayed through the month of March.
Leisure and Learning	March Fitness programs attendance improved to 160. Summer camps planning is in full swing; entirely revamped protocols will be in place to prevent the spread of COVID-19 while preserving the highest possible degree of access. Lifelong Learning is seeing an uptick in participation. The AARP Tax Aide program provided support to 200 patrons in March. They will continue their work until the new May deadline for IRS returns.

Executive Director Activity

Although in-person meetings have been suspended, I have attended ArtsFairfax and Greater Reston Chamber of Commerce board meetings. Health, Housing and Human Services Leadership Team meetings are occurring monthly. There is a Senior Management Team meeting with the County Executive every month. The Master Arts Plan Task Force work continues with Task Force review of the current draft likely to finish in early April, after which it will be moved into other review layers and engagement with County staff on the particulars of the Plan language for arts facilities.
