### 3D Gallery Exhibit Description

We invite area ceramic, sculpture, bead work, mosaics, stained glass, woodwork and other 3D artists to display and sell their work in the 3D Gallery at RCC Lake Anne during this exhibit. The \$2 per-piece entry fee (maximum is eight pieces per artist) will be donated to Cornerstones. Artists are encouraged to donate 10 percent of their sales to Cornerstones to support their work at the Embry Rucker Community Shelter, the Laurel Learning Center and their Community Services Outreach Program. ### 3D Gallery Entry Guidelines

- Original three-dimensional works that meet RCC standards will be accepted.
- **Affix a label to the bottom of each work** that includes your name or initials and price.
- Artists should bring their own display stands, risers, etc. labeled with their name.
- For size limitations, see below. RCC staff will make final placement decisions.
- Sales may be conducted during this special exhibit by RCC with permission from the artist. Artists are solely responsible for sales taxes, which should be included in the price. RCC does not charge sales commission. Sold art may be replaced if coordinated with Cheri Danaher or Gloria Morrow.
- **Please do not enter "Not for Sale" items in this exhibit.**
- Everyone is invited to the Holiday Gift Shopping Event on December 7 from 10:00 a.m. – 3:00 p.m.

### Nature of Reston Community Center Exhibits

Since Reston Community Center is a public facility utilized by all members of our community, the nature of daily activities requires discretion in the type of work displayed. Work that is sexually explicit (work that is representational or realistic in depiction of human genitals will be considered sexually explicit by RCC), or is graphically violent will not be considered appropriate to the space. If artwork that does not meet these guidelines is inadvertently accepted, RCC reserves the right to store the work until the artist can be contacted. RCC staff and artists work together to create an atmosphere that is sensitive to the multi-use nature of the facility.

### 3D Gallery Information

The 3D Gallery, a glorious addition to the Lake Anne facility for three-dimensional art, was completed in September of 2011. Lighted display cases line the walls of a 30' long hallway displaying pottery, sculpture, mosaic and other three-dimensional artworks. Each display case is approximately 4' wide X 6' tall. Within each case are three 4' wide X 2' high shelves. The bottom shelf is a black hard surface material with a depth of 14 inches and the upper two glass shelves are 12.5" deep. The back and sides of the entire display case are mirrored, giving a truly three-dimensional view of the display pieces. Depending on the size of the 3D pieces, three to seven items can be displayed on each shelf.
