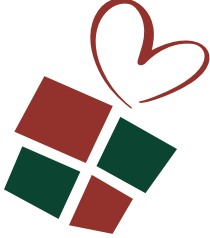


Exhibit Dates: December 1, 2025 – February 20, 2026

3D Gallery Exhibit Description

RCC invites area 3D artists including ceramic, sculpture, beadwork, mosaics, stained glass, woodwork and more to display and sell their work in the 3D Gallery at RCC Lake Anne. The \$2 per-piece entry fee (up to eight pieces) benefits Cornerstones. Artists are also encouraged to donate 10% of sales to support Cornerstones' community programs.

3D Gallery Entry Guidelines

- Original three-dimensional works meeting RCC standards are welcome.
- Label each piece on the bottom with your name or initials and price.
- Artists must provide labeled display stands or risers.
- For size limits, see below; RCC staff will determine final placement.
- Sales may be handled by RCC with artist permission. Prices must include tax. No commission charged. Sold works may be replaced with approval from Cheri Danaher or Gloria Morrow.
- "Not for Sale" items will not be accepted.

Nature of Reston Community Center Exhibits

As a public facility serving all community members, RCC must use discretion in artwork displayed. Works that are sexually explicit (including realistic depictions of human genitals) or graphically violent are not appropriate. If such work is accepted in error, RCC may remove and store it until the artist can be contacted. Staff and artists collaborate to ensure exhibits reflect the multi-use, family-friendly nature of the center.

3D Gallery Information

The 3D Gallery, added to the Lake Anne facility in 2011, features a 30-foot hallway lined with lighted display cases for pottery, sculpture, mosaics and other 3D art. Each mirrored case is about 4 feet wide and 6 feet tall with three shelves, allowing three to seven pieces per shelf depending on size.
