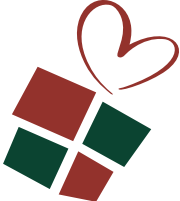


Exhibit Dates: December 1, 2025 – January 5, 2026

RCC invites artists to showcase original two-dimensional works for holiday gift giving. Space is limited to two pieces per artist, first-come basis. Entry fees support Cornerstones; artists are encouraged to donate 10% of sales to support Cornerstones' community programs.

Jo Ann Rose Gallery Entry Guidelines

Artwork Guidelines

Original two-dimensional works in any medium meeting RCC standards are welcome. Pieces over 36" in any direction count as two. Off-white or white mattes and simple frames are preferred.

Hanging Requirements

All works must have a secure hanging wire. Gallery-wrapped canvases do not require frames unless staples are visible; canvas edges should be finished. Unsafe pieces will be returned. Staff will make final hanging decisions.

Labeling

Attach a temporary front label with your name, title and price. Permanent wall tags will be added later.

Sales

RCC may conduct sales with artist permission. Prices should include sales tax. No commission is charged. Sold works may be replaced with approval from Cheri Danaher or Gloria Morrow.

Liability

RCC is not responsible for loss or damage, though staff take all reasonable precautions. Artists exhibit at their own risk.

Additional Notes

Only works for sale are eligible.

Nature of Reston Community Center Exhibits

As a public facility serving the entire community, RCC exercises discretion in the artwork displayed. Works that are sexually explicit or graphically violent are not appropriate for exhibition. If a piece is later found to fall outside these guidelines, RCC may remove and store it until the artist can be contacted. Staff and artists work together to maintain a welcoming environment for all visitors.

Jo Ann Rose Gallery Information

Opened in 1999, RCC Lake Anne is a multi-use facility with a strong focus on visual arts. The Jo Ann Rose Gallery, dedicated to artist and former RCC Board member Jo Ann Rose, showcases monthly exhibits featuring local artists and up to 40 works. Jo Ann's leadership and vision helped create this special space celebrating community art.
